

Arachnid A28 Battery Installation:

1. **Unscrew bottom Cap counter clockwise from Body and remove Battery Cartridge.**
2. **Insert 3 new batteries into Cartridge. Install negative side of battery (flat side) toward battery springs (2 up and 1 down).**
3. **Slide Battery Cartridge into flashlight Body with the positive side towards Body and negative side towards bottom Cap.**
4. **Screw cap on clockwise.**
